I. Eligibility Criteria:

Bidder should have at least one goods vehicle (having highest load capacity they are quoting) in their own possession.

II. How to apply:

1. Duly signed and sealed **Quotation in letter head/white paper** (in the format attached) with Communication address and contact Numbers and EMD in a single cover addressing to Deputy Manager (C) superscribing **“Quotation for Light Commercial vehicle”**.
2. Earnest Money Deposit (EMD): Rs 2000/- (Rupees Two thousand only). EMD can be paid by DD favouring The Travancore Cements Ltd payable at Kottayam/directly to company by cash on all working days (9 am to 3 pm). Deposits of those bidders already existing with Company need not pay deposits again. However they have to produce documentary proof of deposits along with bid.
3. Copy of PAN, Vehicle RC, insurance etc shall be submitted along with bid.

General Terms.

1. Vehicle offering should have valid RC, fitness, insurance and all other relevant valid records as per law.
2. Vehicle offering shall not have any liabilities, cases and any other legal issues.
3. Contractor shall have good quality Tarpaulin to cover the loads to avoid getting wet. Damages met by TCL during transit if any will be recovered from transporter.
4. Company will verify the ownership and possession of goods vehicle. Bidder also needs to produce relevant document of the vehicle(s) to Company on demand.

5. Company will not provide fuel/fuel charges.
6. Maintenance charges, taxes, insurance, driver wages (if delivering auto with driver), other charges (if any), spares, manpower and facilities required for maintenance etc are on to the account of bidder and company may not offers the same.
7. Bidder has to arrange vehicle by their own cost and risk. Vehicle may be arranged immediately on receipt of intimation from company so as to place vehicle with in one hour of intimation received.
8. Bidder shall observe all the rules/regulations/orders of Central and State Government and local authorities in operating the vehicles. If any breach of the said rules/orders, the bidder shall be solely responsible for this.
9. The bidder should not transport persons other than company products in the Vehicle. Vehicle should bear the board of “**On contract With TCL**” while transporting company products. Under no circumstances, the board may be exhibited while transporting other than Company products.
10. The company reserves the right to apportion the contract to as many bidder(s) as required. Company also have right to enter into parallel contracts simultaneously or at any time during the period of contract with one or more bidder(s) as company may think fit.
11. Company reserves the right to accept and or reject any or all the bids without assigning any reason whatsoever. Company does not bind itself to accept the lowest bid or assign any reason for non-acceptance of the same.
12. Company will have the liberty to cancel/suspend the contract without notice at any time if the performance is found not satisfactory. However the bidder will have to give a notice period of 1 month for cancellation of contract from their part for the company to make alternate arrangement.
13. Company is empowered to forfeit the EMD at its discretion, in case the bidder fails to obey the contractual obligations, terms and conditions. Company also have the right to claim further damages that may be fixed by the company as being the loss or damages suffered by it due to violations of any of the conditions of the contract.
14. There shall not be any employee-employer relationship. Hence claim for employment from personnel’s of bidder’s side will not be entertained.
- 15. Payment: Payments will be made weekly basis against submission of bill.**
16. INDEMNITY: In case the company suffers any loss or damages due to any act or omission on the part of the bidder, the bidder shall be liable to indemnify the company to the extent of the damages suffered by the company.
17. COURT OF JURISDICTION: The legal jurisdiction of the contract shall be the competent court at Kottayam, Kerala only.
